## Representative Experience

- Successfully defended School Board on claims of violations of First and Fourteenth Amendment Rights and of the Equal Educational Opportunities Act arising out of school names. The School Board prevailed on a Motion to Dismiss, and the case was resolved during the appeal to the Fourth Circuit.
- Successfully represented off duty police officer in shooting death case. After almost three years of litigation in Federal Court, the plaintiffs dismissed the case with prejudice.
- Resolved State Court case in which Plaintiff suffered severe injuries after officer deployed Taser.
- Resolved tragic case involving freshman who died at a college fraternity against allegations of excessive drinking and hazing.
- Obtained early settlement of wrongful death case where elderly man was run over at defendant's premises after fall on ice.
